Surrogacy is legal in the UK, although UK laws may seem outdated in comparison to similar laws in more “surrogacy friendly” countries. For example, under British law the surrogate mother is regarded as the legal mother regardless of any contract with the Intended Parents. A Parental Order is then issued to establish permanent parental rights.
